

**GRAND CANYON HOUNDS, INC. & GRAND CANYON STABLES**  
**Waiver and Release of Liability**

In consideration for permission to participate in activities of Grand Canyon Hounds, Inc. and Macarco VII, LLC, doing business as Grand Canyon Stables (collectively, "Hounds"), I, the undersigned, agree to the following waiver and release of legal rights, and I **ACKNOWLEDGE THAT, BY SIGNING THIS WAIVER AND RELEASE OF LIABILITY ("RELEASE"), I AM GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF INJURY, DEATH OR PROPERTY DAMAGE:**

1. Limited Permission: I understand and agree that the permission is granted to allow me to: (i) participate in staging equestrian activities; (ii) participate in equestrian activities; (iii) have limited access to the Hounds' property (as otherwise permitted under the Hounds' Rules & Regulations), upon which are horses and hounds; and (iv) participate as a spectator while at equestrian activities. I agree to limit myself to these activities and no others.

2. Acknowledgment and Assumption of Risk: I know that horseback riding and other activities involving the use of horses and hounds, whether or not located on Hounds' property, including, but not limited to, fox hunting, trail riding or schooling, horse training, riding, horse shows, point-to-point racing, pairs racing and hunt club team racing, are athletic events that are potentially dangerous activities (the "Activities"). I know that horses and hounds can behave in unpredictable and dangerous ways. Horses and hounds can be provoked by unanticipated sources (such as noise, movement and other animals and creatures). I know that, should I participate in any Activities of Hounds, I can expect to face hazards and risks associated with both the Activities and the conditions of the property and terrain, including rocks, ruts, roots and ravines, loose and wet earth, slippery, icy and snow-covered conditions, fences, jumps and obstacles, brush and trees, and dangerous animals and reptiles. I can and will face choices involving risk to my person and property that can result in my death or serious injury, and damage to my property. On behalf of myself, my heirs, executors, administrators and assigns, I hereby voluntarily assume all risk of personal injury and property damage, and accept responsibility for any and all damages that may occur as a result of any personal injury, disability, death or property damage. I understand that I may, at any time, cease my participation in any or all of the Activities or limit my participation at the time of the event, and that by continuing partial or full participation, I have assumed the risk of all dangerous activities as set forth above.

3. Release: Having considered all the risks to my person and my property, whether those risks are known or unknown, foreseen and unforeseen, future or contingent, on behalf of myself, my heirs, executors, administrators and assigns, I voluntarily agree to forever release Grand Canyon Hounds, Inc. and Macarco VII, LLC and their respective officers, directors, partners, members, employees, volunteers, lessees, guests, invitees, licensees, and agents, along with any event sponsors, and any and all landowners, permitors, licensors and all others who have granted Hounds access to conduct events, and all of their respective successors and assigns (the "Released Parties") from any and all liability and claims of injury, damage and harm of whatever kind and nature however caused, including, without limitation, resulting from the negligence or other acts of any of the Released Parties.

4. Indemnification and Covenant Not To Sue: On behalf of myself, my heirs, executors, administrators and assigns, I agree to indemnify, defend and hold harmless the Released Parties from any and all claims, demands, actions or lawsuits for any injury, damage or harm of whatever kind and nature which result in whole or in part from my actions, failure to act or negligence. I agree that I shall never bring, commence, prosecute, or participate in any action, suit or other proceeding against the Released Parties arising out of, concerning, or related to, participation in the Activities as defined above, or actions and omissions of the Released Parties, including, without limitation, the negligence, of the Released Parties.

5. Authority: Binding Effect: I have full power, authority, capacity, and right, without any limitation, to execute, deliver and perform this Release. This Release shall be binding upon me and my spouse, legal representatives, heirs, successors, and assigns, and shall inure to the benefit of the Released Parties. This Release shall be governed by the laws of the State of Arizona. If, for any reason, any provisions of this Release shall be determined by a court of competent jurisdiction to be invalid, unenforceable, illegal, or inoperable, I agree that its invalidity shall not affect the validity and effect of the other provisions herein.

6. Helmet and Protective Gear: I am advised to wear a helmet and protective gear for my own protection. I have checked the box indicating my understanding of this advice.  (check box to show read)

**I REPRESENT AND WARRANT THAT I AM OVER THE AGE OF 18, HAVE CAREFULLY READ THIS RELEASE BEFORE SIGNING AND FULLY UNDERSTAND ITS CONTENTS. I CERTIFY THAT I AM THE LEGAL GUARDIAN OF THE MINOR CHILD(REN) LISTED HEREIN. MY SIGNATURE INDICATES MY UNDERSTANDING ON BEHALF OF MYSELF, AND, IF APPLICABLE, THE MINOR CHILDREN LISTED HEREIN, OF MY AGREEMENT TO ITS TERMS AND TO MY KNOWINGLY AND WILLINGLY WAIVING RIGHTS AS SET FORTH IN THIS RELEASE, IN ACCORDANCE WITH ARIZONA REVISED STATUTES §12-553. I AM AWARE OF THE INHERENT RISKS ASSOCIATED WITH EQUINE ACTIVITIES, AM WILLING AND ABLE TO ACCEPT FULL RESPONSIBILITY FOR MY OWN SAFETY AND WELFARE AND THAT OF THE MINOR CHILD(REN) FOR WHOM I AM SIGNING, AND I RELEASE THE RELEASED PARTIES FROM LIABILITY. I AM AWARE THAT THIS IS AN ASSUMPTION OF RISK AND RELEASE OF LIABILITY AND SIGN IT OF MY OWN FREE WILL. I UNDERSTAND THIS RELEASE IS A PROMISE NOT TO SUE AND A RELEASE AND INDEMNITY FOR ALL CLAIMS, INCLUDING MY RIGHT TO SUE FOR DAMAGES, INCLUDING THOSE CAUSED OR ALLEGED TO BE CAUSED BY THE RELEASED PARTIES' NEGLIGENCE OR WILLFUL MISCONDUCT.**
